

**CITY OF MARATHON, FLORIDA
RESOLUTION 2010-19**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVING CERTAIN PURCHASES IN EXCESS OF \$10,000 AND LESS THAN \$25,000; WAIVING THE CITY'S PURCHASING POLICIES AND PROCEDURES; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO ENTER INTO AGREEMENTS IN CONNECTION THEREWITH; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Council of the City of Marathon, Florida (the "City"), adopted purchasing policies and procedures after determining that it was fiscally prudent and in its best interests to adopt policies and procedures regarding the purchasing and acquisition of contractual services, equipment, goods, professional services and other similar types of services (the "Purchasing Policies and Procedures"); and

WHEREAS, pursuant to Resolution 2007-156, the City Council amended the Purchasing Policies and Procedures to provide that any purchases over \$10,000 and less than \$25,000 must be placed on a City Council agenda as a consent item for approval prior to execution of the contract or consummation of the purchase; and

WHEREAS, the City Manager recommends the City Council waive the City's purchasing policies and procedures due to the sole source status of the vendor listed in Composite Exhibit "A;" and

WHEREAS, the City Manager has authorized staff to prepare purchase orders for those items set forth in Composite Exhibit "A," attached hereto and now wishes to bring them before City Council as a consent agenda item.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

Section 1. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Based upon the recommendation of the City Manager, the City Council finds that Marino Painting is sole source vendor for the purchase approved herein.





Work to be performed at: Marathon Amphitheater

SCOPE OF WORK: Complete painting of all steel , to include all painted clamps, tie backs and all other steel attached to fabric cover.

WORK TO BE PERFORMED

All Painted steel: Mechanically grind all rusted areas to bright metal.

Sand all steel to allow for adhesion of new coatings.

Solvent wipe all steel to remove any oils, etc: from steel prior to application of any coatings, pressure clean all steel to remove all loose,peeling and chalking paint and to remove any foreign debris detrimental to adhesion of new coatings.

Prime all bare metal with 2 part Epoxy-Mastic high build rust inhibitive primer, Stripe prime all welds throughout structure with 3 inch stripe.

Finish coat all steel with gloss 2 part Aliphatic urethane coating to match existing color.

All work to be brush and roll no spraying will be done on jobsite,

All work to be done in a manner as to alleviate as much disruption of normal business as possible

All areas to be cleaned up at end of work each day.

All surrounding areas will be protected while work is being performed

Upon completion jobsite will be left neat and clean.

City of Marathon to supply man lift for completion of work,

MARINO PAINTING to supply all fuel for equipment,

Any alteration or deviation from specifications involving extra costs will; be executed only upon written orders from customer and will become an extra charge over and above the estimate
