RESOLUTION 2019-95

A RESOLUTION OF THE CITY OF MARATHON, FLORIDA, ADOPTING THE TENTATIVE MILLAGE RATE AND LEVY OF AD VALOREM TAXES FOR THE CITY OF MARATHON, FLORIDA FOR FISCAL YEAR 2019-2020; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, pursuant to Section 200.065, *Florida Statutes* the City of Marathon, Florida (the “City”) has established a proposed millage rate; and

WHEREAS, pursuant to Section 200.065(2)(c), *Florida Statutes*, within eighty (80) days of certification of taxable value the City must re-compute the proposed millage rate and adopt a tentative millage rate; and

WHEREAS, on September 12, 2019, the City Council held a public hearing to consider any adjustment of its proposed millage rate, to consider its tentative operating budget for Fiscal Year 2019-2020 (“FY 2019-2020”), and adopt a tentative millage rate in accordance with Section 200.065, *Florida Statutes*.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA AS FOLLOWS:

Section 1. The foregoing recitals are true and correct and are incorporated herein by this reference.

Section 2. The FY 2019-2020 tentative millage rate for the City is 2.59 mills, which is \$2.59 for each thousand dollars of taxable assessed property value; and the tentative millage rate is greater than the rolled-back rate of 2.4459 mills by 5.89%.

Section 3. This resolution shall be effective immediately upon its adoption.
