**RESOLUTION 2020-67**

**A RESOLUTION OF THE CITY OF MARATHON, FLORIDA, ADOPTING THE TENTATIVE MILLAGE RATE AND LEVY OF AD VALOREM TAXES FOR THE CITY OF MARATHON, FLORIDA FOR FISCAL YEAR 2020-2021; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, pursuant to Section 200.065, *Florida Statutes* the City of Marathon, Florida (the “City”) has established a proposed millage rate; and

**WHEREAS**, pursuant to Section 200.065(2)(c), *Florida Statutes*, within eighty (80) days of certification of taxable value the City must re-compute the proposed millage rate and adopt a tentative millage rate; and

**WHEREAS**, on September 10, 2020, the City Council held a public hearing to consider any adjustment of its proposed millage rate, to consider its tentative operating budget for Fiscal Year 2020-2021 (“FY 2020-2021”), and adopt a tentative millage rate in accordance with Section 200.065, *Florida Statutes*.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA AS FOLLOWS:**

**Section 1.** The foregoing recitals are true and correct and are incorporated herein by this reference.

**Section 2.** The FY 2020-2021 tentative millage rate for the City is 2.59 mills, which is \$2.59 for each thousand dollars of taxable assessed property value; and the tentative millage rate is greater than the rolled-back rate of 2.4631 mills by 5.15%.

**Section 3.** This resolution shall be effective immediately upon its adoption.
