This cybersecurity package is needed for city-wide security and monitoring of computers and email, this will greatly enhance and shield the city from future cyber-attacks. WHEREAS, the City of Marathon (the "City") has been using Crypsis Group for incident response monitory software City wide for cybersecurity protection and monitoring of all computers and office 365 email since March of 2020; and
