Bartus added a Rotary 60th Anniversary Proclamation as item B2 on the agenda. Zieg added Ordinance 2013-05 (Vehicle for hire), Garrett added Fitness Court as item K and Area 3 wells as item L.

With no objection from the members of Council, Mayor Gonzalez declared the motion approved by unanimous consent.

City Council Items:

* Approval of Minutes

Red Ribbon Week Proclamation (Mayor Gonzalez) The Council presented the proclamation to Dr. Belotti and the students at Marathon High School Keys To Be The Change group. Dr. Belotti invited everyone to the October 28th celebration event from 6-9 pm and informed everyone there would be information for parent education.

Fitness Court Art Contest Finalist – the finalist was announced as artist Andrea Munchmeyer. The Mayor thanked everyone who participated.

Building Inspection Ordinance 2021-18 Discussion (Councilmember Zieg) Zieg explained we had been discussing multi story buildings and the words "multi-story" was left out. Zieg asked the council to consider inserting the words "two stories or higher". Bartus agreed. Senmartin disagreed and commented that there was a building that was falling in and it is a one story. Martinez spoke regarding the ordinance and informed the Council that Miami Dade County has evacuated a total of five building so far that were in disrepair. Zieg commented that with the current system, any complaints can prompt an inspection and suggested we discuss this at the next meeting so that Councilmember Cook could weigh in. Martinez commented that 2,000 square feet would need to be removed from the ordinance as well. Bartus questioned the City's limits/liabilities. Williams explained that anything the building official says goes and suggested that next month we discuss the procedure of an unsafe building and the best way to go about it. Surfside has a defense, but the second municipality this happens to will not have a defense. Gonzalez suggested bringing this back. Council agreed.

Request to Waive Fees and Allow Beer and Wine at the Celtic Fest to be held at Community Park January 8th and 9th.

Ordinance 2015-05 Discussion (Councilmember Zieg) explained that according to the ordinance, the City must do inspections of the taxi vehicles for safety, as well as verify insurance and driver's licenses. Zieg suggested that since we are currently not conducting the inspections that may leave us open for liability. Zieg suggested to either start inspections of the vehicles for hire and verifications of driver's licenses and insurance or drop this from our code.

Roger with Native Taxi spoke for the ordinance being enforced and asked for Lyft and Uber to be included.

Michele Flay spoke for the ordinance being enforced since not everyone was properly insured and were operating at an advantage since commercial insurance is more expensive.

Senmartin commented he would like to enforce what we have.

Bartus questioned what costs were involved. Williams commented time and manpower.

Gonzalez commented that there were nine or ten different taxi signs and taxis are the first impression of our town. The mechanism is in place and asked for an update at the next meeting and to reactivate in January.

Boat Ramp Launch Fees – Solis explained staff was still working out the logistics for restricting the access to the 33rd Street and Harbor boat ramp to automatically collect fees for the use and parking at these facilities as well as addressing potential parking fees at Sombrero Beach for the Council's consideration.

Solis explained as a starting point, he asked the Council to consider a \$20 fee to use the ramp, in and out, and an additional \$20 fee to use the parking at the ramp for a total of \$40 if you use the parking facilities and the ramp. Solis suggested the City of Marathon residents could purchase a yearly pass for \$100 per year for unlimited use at all boat ramps. Solis explained the Harbor Boat Ramp would be a challenge for equipment because of high tides. Solis explained this was a starting point, and he would like to bring something back in December so that staff has time to work out the logistics for the 33rd Street ramp and Harbor Ramp, have an estimate cost for initial capital investment and operating cost to manage and enforce the parking at these facilities, and provide a schedule for implementation. Solis reported that staff will also be providing information of the different systems available and make recommendations accordingly.

Zieg questioned if Key Colony Beach would be included, as this will come up a lot especially with all their vacation rentals. Gonzalez suggested bringing this back in December when Councilmember Cook could also weigh in.

Laurence Troiano from Key Colony Beach stated his concerns and questioned if staff knew how many vehicles use the boat ramp and that there were a huge number of tourists.

City Manager Report:

Legislative Priorities – Garrett explained that last year's priorities were in the packet, and he went over the current priorities and asked for approval to move forward with the City's state and federal lobbyists. Bartus commented he was surprised that Monroe County was not taking a more active roll in takings cases. Senmartin commented he was waiting for the census data combined with the evacuation model he felt we may get more allocations.

Mayor Gonzalez acknowledged Sherriff Ramsay.

Allowing Beer and Wine at a November 6th Private Event at Community Park

Bartus recused himself.

Garrett explained this was for a wedding reception which was also a fundraising event benefitting the Marathon Rotary and Presents in Paradise.
