In The Current Amount Of \$131,230.50 For Additional Grading And Replacement of Additional Damaged Asphalt; Increasing The Contract In An Amount Not To Exceed \$22,809.00; Authorizing The City Manager To Execute The Change Order And Appropriate Funds On Behalf Of The City; And Providing For An Effective Date.

## BACKGROUND & JUSTIFICATION:

On December 21, 2020, the City entered into an agreement with Discount Rock & Sand, Inc for the construction of Stormwater Improvements in the Sombrero Area. The area of work was complete, and we determined that additional grading in the area is required to make better use of the stormwater system installed to allow the rising water from king tides to freely flow back to the inlets installed. We will also take advantage of the work being performed to install gravel instead of sod in the vicinity of the new inlets as this material will perform in wet conditions better than sod. The cost includes the credit for the sod and restoration work included in the original bid.

In addition, while the paving crew were on-site, we determined that there were additional areas of damaged asphalt that should be replaced during this operation, and this cost is included in the CO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA APPROVING CHANGE ORDER NO. 6 TO CONTRACT BETWEEN THE CITY AND DISCOUNT ROCK & SAND, INC. IN THE CURRENT AMOUNT OF \$131,230.50 FOR ADDITIONAL GRADING AND REPLACEMENT OF ADDITIONAL DAMAGED ASPHALT; INCREASING THE CONTRACT IN AN AMOUNT NOT TO EXCEED \$22,809.00; AUTHORIZING THE CITY MANAGER TO EXECUTE THE CHANGE ORDER AND APPROPRIATE FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Marathon (the "City") approved the agreement with Discount Rock and Sand (the "Contractor") in December of 2020 for the Sombrero Stormwater System improvements and Repair project; and

WHEREAS, it was determined that additional grading in the area is required to make better use of the stormwater system. We will also take advantage of the work being performed to install gravel instead of sod in the vicinity of the new inlets as this material will perform in wet conditions better than sod. This change order also addresses the cost of the additional pavement repair requested by the City, that was not a result of the work performed and includes the credit for the sod and restoration work included in the original bid; and

**WHEREAS**, the City finds that approving this change order with the Contractor is in the best interest of the City.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

- **Section 1**. The above recitals are true and correct and incorporated herein.
- **Section 2**.
