## Approval of Agenda & Consent Agenda

Zieg added Resolution 2022-36 to the consent agenda, added Transportation Committee update as item 5E and added FKAA billing discussion as item 5F. Garrett added staff reports to the consent agenda except Sherriff's office report, Public Works report and Code report.

# \* Approval of Minutes

BPAS Donation Payments – Shea explained the proposed updates and recommended changes to the First Time Homebuyer Program, which would come back in the form of ordinances and resolutions.

Brian Tewes questioned a few of the items in the memo and stated his concerns with the changes.

Josh Mothner explained he was the City contractor for this program and explained the program and recommended changes.

Zieg asked the Council if they would be comfortable letting Tewes, Mothner and Shea iron out any kinks and move forward with the discussion Tewes brought forward. Council gave a head nod.

Friends of Old Seven – Andy Newman gave a video presentation regarding the reopening of the old Seven Mile Bridge and commented that this was the biggest tourism story of the year for the Florida Keys and over 1.16 million people were reached via social media. Bernard Spinrad with Save Old Seven thanked Newman, FDOT, Monroe County Commissioners and staff, the City of Marathon, and the community. Spinrad explained Save Old Seven would be dissolving as they have accomplished their missions and presented a check for \$18,000 to the City to help offset costs of providing restroom facilities in Sunset Park.

Smart Ride November 19, 2022 Request

**MOTION:** Gonzalez moved to approve the request.

With no objection from the members of Council, Mayor Bartus declared the motion approved by unanimous consent.

Transportation Committee (Zieg) Zieg explained the list of recommendations to help alleviate traffic congestion, twelve recommendations that are primary priority projects that will be sent to FDOT and the County and municipalities will adopt at their next meeting and another list of secondary priorities that come to fruition over the next couple of years.

FKAA Billing (Zieg) Zieg explained that the FKAA was imposing a 2.5 percent increase across the board that will take affect on October 1<sup>st</sup> due to those who use credit cards to pay their bill costs them more than those who write a check. Zieg explained he wanted the public to be aware that everyone will have this increase whether or not they pay by credit card or check.

## **City Manager Report:**

MCSO Marathon Substation Report – Detective Sgt. Lissette Quintero gave an overview of the report and commented that the Seven Mile Bridge Run was a success. Sherriff Ramsay provided a check in the amount of \$51,000 to the City due to funds that were not spent as he does every year.

# \*Grants Update

Public Works Report – Solis reported that the City recently secured just over \$1 million from a federal fund to fix Coco Plum Bridge. The bridge design will start immediately, rather than make temporary fixes while waiting for other funding cycles from the state Department of Transportation. Solis informed everyone we have already started the process; we have our consultants under contract and the construction should be complete by the end of the year.

Jean Tarlton stated she was relieved and thanked the Council, Garrett, Clavier, Williams, Johnson, Covelli, Solis, Mullins, and Shea.

Park and Recreation Report – Garrett asked for head nods for the Rotary Park brick fundraiser. The Council approved the selling of bricks to help offset the costs of the repairs and improvements to Rotary Park.

Code Report –Lozier informed everyone staff was continuing to evaluate proposals of two companies that provide vacation rental property monitoring systems and staff is now following up with all complaints with the status of the complaint/results of the case or complaint. Zieg asked if we were moving forward with the inspection of taxi's that we asked for in October, as last month one taxi service had been registered. Lozier replied they were moving forward and since last month and now have two companies registered and sent notice of violations to four companies and working with three others. Zieg questioned since last month's adoption of the new sign ordinance how many signs have been picked up. Lozier reported no signs have yet been picked up.

Garrett informed everyone that the fitness court grand opening would be held April 22<sup>nd</sup> at 11:00 am.

Byron Goss – spoke in favor of the Resolution.

Joy Doumis – spoke for the resolution and informed everyone her mailbox and driveway get blocked from people who are parking to go to the beach.

Gonzalez commented he had concerns of a child being hurt and that there were also issues with Coco Plum Beach and since the Fills were closed it has become worse. Gonzalez stated when the parking is full, the beach is full, he had witnessed motor homes taking up many parking spots as well as busses dropping off people. Gonzalez stated he was 150 percent in favor of restricting parking and having an overflow parking lot on Coco Plum. Zieg suggested the signs stating no bus or RV parking be restored. Still commented that she also had concerns regarding safety of cars parking or blocking the sidewalk. Gonzalez

suggested the chamber could assist with shuttles from resorts to drop off their guests may help. Sherriff Ramsay suggested that the deputies could not be there every fifteen minutes to patrol and if they issue a parking ticket, the car or bus is still taking up a spot for the day and suggested instead to tow at the owner's expense.

Chelsea Lyons – asked the Council to include side streets.

Williams commented that the Resolution would need to be amended and suggested those on the side streets contact the city to have signage and we will find a way to make it work. Zieg suggested to discuss Coco Plum at the next meeting.

#### **Citizen Comments**

Ingrid Tyree – commented that no one is open in government on the weekend, and some people are recently without a home, and she is trying to help them by letting them put up tents in her yard temporarily and the tents will be stored in the old fire station.

Williams explained there were federal laws and referenced KOTS in Key West and explained it was a kind thought and idea, but vastly reaching.

Diane Scott – commented that she needed a high chair and everywhere she sits she has a high chair. Scott complained that there was not a tiki hut at Jesse Hobbs park and a fence was to be put up, her church

windows were broken, there were dogs at the beach and told everyone not to close the chamber door because she cannot breathe when it is closed and commented that the City was racists.

#### **Council Comments**

Still commented that everyone on the Council is here to make Marathon better and thanked everyone who contacted the Council with their concerns. Still thanked the staff and her fellow councilmembers.

Gonzalez thanked staff and the citizens for their emails.

Zieg gave an overview of historical events that happened on this date, thanked staff, and commented that the first-time homebuyers program is an excellent program that needs tweaking. Zieg commented that it was great to see interested citizens attend the meeting.

Bartus thanked staff, Brian Tewes and Josh Mother and commented that government is best with participation. Bartus commented regarding the Mayors of Ukraine who along with their families were being tortured and killed, 11 mayors were in Russian custody, and he hoped it would end soon.

With no further business to come before the Council, Mayor Bartus adjourned the meeting at 6:57 pm by unanimous consent.
