BACKGROUND & JUSTIFICATION:

The Florida Department of Economic Opportunity (DEO) awarded the City a \$5,000,000 grant for the Purpose of Implementing the CDBG0DR Home Buyout Program in order to reduce flood risk in future hurricane events.

An appraisal was made and the offer amount of \$275,000 was accepted by the property owners and initial approval was gained by the Florida Department of Economic Opportunity.

Pending final approval by DEO, the City of Marathon will complete the purchase of the property and demolish any structures on the property and restore the property to a green space, stormwater drainage, or for recreational purposes in perpetuity.

WHEREAS, the City of Marathon will commit to demolishing any structures on the property and restore the property to a green space, stormwater drainage, or for recreational purposes in perpetuity; and

WHEREAS, the Marathon City believes the purchase of this property will help mitigate the area against future loss due to flooding.
