CITY OF MARATHON, FLORIDA RESOLUTION 2022-55

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AMENDING THE AMBULANCE FEE SCHEDULE MILEAGE **CHARGE** AND AUTHORIZING RATE **INCREASES** MEDICARE INCREASES ITS RATES: AS AND **PROVIDING AN EFFECTIVE DATE**

WHEREAS, the City of Marathon, Florida (the "City"), pursuant to City Resolution No. 02-12-15, adopted a fee schedule for providing ambulance service (the "Fee Schedule"); and

WHEREAS, the City amended the Fee Schedule pursuant to Resolution 2009-151; and

WHEREAS, the City amended the Fee Schedule pursuant to Resolution 2008-060; and

WHEREAS, the City has a responsibility to provide Emergency Medical Service (EMS) transport services; and

WHEREAS, the cost of providing EMS transport services has increased due to inflation; and

WHEREAS, the City wishes to authorize automatic adjustments to the ambulance mileage rate fees based on the yearly adjusted Medicare rates.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

Section 1. The above recitals are true and correct and incorporated herein.

Section 2. The City Council hereby amends the fee schedule as set forth on Exhibit "A" attached hereto and incorporated herein.

Section 3. The City Council hereby authorizes the City Manager to make automatic adjustments to the ambulance mileage rate fees to equal the fees allowed by Medicare.

Section 4. This resolution shall take effect immediately upon its adoption.
