Agenda Item: **Resolution 2022-79** Approving A Grant Agreement Between The City Of Marathon And The Florida Department Of Agriculture And Consumer Services For Purchase Of Radios And Equipment Of Marathon Fire Rescue; Appropriating Funds; And Providing For An Effective Date

#### BACKGROUND & JUSTIFICATION:

The Florida Department of Agriculture and Consumer Services awarded the City a grant for The Monroe County Tourist Development Council awarded the City a grant through the FY2021 Volunteer Fire Assistance Grant program for the Purchase of New Radios and Accessories. The grant amount is for \$10,000.00. The total cost of the Project is approximately \$34,883.00 with the City funding the difference.

#### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVING A GRANT IN THE AMOUNT OF \$10,000 FROM THE FLORIDA DEPARTMENT OF AGRICULTURE AND CONSUMER SERVICES TO ASSIST IN THE PURCHASE OF NEW RADIOS AND ACCESSORIES FOR MARATHON FIRE RESCUE; APPROPRIATING FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Marathon, has submitted a grant application to the Florida Department of Agriculture and Consumer Services for participation in their Volunteer Fire Assistance Grant program; and

**WHEREAS**, the City of Marathon has been awarded and will accept a \$10,000 grant from the Florida Department of Agriculture and Consumer Services, and provide a local match of \$24,882.46 to purchase new radios and accessories; and

**WHEREAS**, the City of Marathon believes that Marathon Fire Rescue is in need of new radios and accessories for best communication practices.

#### NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

Section 1. The above recitals are true and correct and are incorporated herein

**Section 2**. The City of Marathon will collaborate with the Florida Department of Agriculture and Consumer Services for reimbursement of funds expended.

Section 3. This resolution shall take effect immediately upon its adoption.


