BACKGROUND & JUSTIFICATION:				
The attached contract and Resolution was made into agreement on October 23, 2018. Since that time Hawkins has been required to increase the costs of the chemicals for the wastewater treatment plants to go into effect on October 1, 2022.				
The increase is due to the pandemic, trucking shortage, supply chain crisis, labor shortage, and global fuel increase. Staff recommends approval.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, RATIFYING A CHANGE TO THE AGREEMENT BETWEEN THE CITY OF MARATHON, FLORIDA AND HAWKINS, AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Marathon, Florida (the "City"), and Hawkins (the "Contractor") entered into a Contract on October 23, 2018; and

WHEREAS, on July 28, 2022 the City received a letter from the Contractors stating the increase cost of goods effective October 1, 2022 due to circumstances beyond their control; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

- **Section 1**. The above recitals are true and correct and incorporated herein.
- **Section 2**. The letter from the contractor, a copy of which is attached as Exhibit "A," is hereby approved and ratified. The City Manager is authorized to execute the agreement on behalf of the City.
 - **Section 3**. This resolution shall take effect upon its adoption.

Hawkins Inc. would like to inform you that we will not be able to continue the pricing for a renewal year beginning in October 2022. The chemical markets continue to build, and we have seen increases of 60 to 100% in past year. All expectations are that this will continue for next 9 months at least. We would be open to an alternative pricing for your products and would suggest a quarterly price for three months with 30-day notice of any increases. This will allow us to move with the market and not have to anticipate the scenario that current market is in. Libby and Dan,

Hawkins Inc. would like to amend your pricing for the next year due to chemical market conditions. We would like to suggest the following price increases to begin on October 1, 2022, when bid would renew. The following increases are due to continued increases in the chemical industry as well as increases in transportation and labor. In addition, Hawkins has strived to maintain our supply to make sure our accounts are taken care of and secured volume to keep up with our customer needs. The other product, Aluminum Sulfate would stay at those same bid prices though we have also had increases on this product also. Hawkins would also be open to a quarterly pricing quote to allow room to adjust both up and down with current market conditions, this would also have a 30 day notice of any change before end of quarter.

Caustic Soda 50% from \$3.39 per gallon to \$5.39 per gallon

Sodium Hypochlorite from .99 per gallon to \$1.45 per gallon

Micro C Glycerin from \$3.39 per gallon to \$5.50 per gallon
