**WHEREAS**, the City of Marathon, has submitted a grant application to the Florida Keys Council of the Arts for participation in the Art Builds Community grant program; and

**WHEREAS**, the City of Marathon has been awarded and will accept a \$10,000 grant from the Florida Keys Council of the Arts, and will provide project assistance to the chosen artist(s); and

**WHEREAS**, the City of Marathon will utilize the “Pre-Qualified Artist Listing” adopted by Monroe County to choose the artist(s) best suited for the installation; and

**WHEREAS**, the City of Marathon believes that connecting the community and visitors to visual aids to help understand the effects of sea level rise and climate change is vital.
