Cook thanked every employee, whether they fill pot holes or give legal advice.

Zieg thanked the responders and workers before, during and after Hurricane Ian. Zieg thanked each staff member and his fellow Councilmembers for a pleasant atmosphere of working well together and commented that it has been a pleasure to work with this Council. Zieg gave an overview of historical events that happened on this date.

Bartus thanked Garrett, Chief Johnson for working with him during Hurricane Ian. Bartus commented on all of the conspiracy theories and gave an example that there was a rumor that officials and senior staff were given \$50,000 Visa gift cards by developers as well as the rumor that the FBI was waiting to pounce on local officials for all of the corruption in City Hall, or the rumor that if a certain candidate is elected to Council, he would be installed as City Manager. Bartus asked everyone to put their trust in actual facts and real audits and make informed decisions this November.
