#### **BACKGROUND & JUSTIFICATION:**

During our yearly hose inspection on the apparatus, it was determined that a large volume of hose was unusable. Due to the volume of damaged hose and urgency, immediate replacement is necessary. Quote for replacement from TEN-8 is piggybacked off the Lake County Contract #22-730k.

### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AUTHORIZING THE PURCHASE OF PRO-FLOW YELLOW HOSE FOR EMEREGENCY REPLACEMENT IN AN AMOUNT NOT TO EXCEED \$37,650.00.; AUTHORIZING THE CITY MANAGER TO APPROPRIATE FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, our yearly hose inspection on the apparatus rendered failing results. It was determined that a large volume of hose was unusable. Immediate replacement is necessary due to the amount of damaged hose and urgency; and

**WHEREAS,** the cost of the replacement hose is \$37,650.00; piggybacked off the Lake County Contract #22-730k; and

#### NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, that:

**Section 1**. The above recitals are true and correct and incorporated herein.

**Section 2.** The City Council hereby waives the procurement procedures requiring competitive bidding and authorizes the City Manager to expend budgeted funds with TEN-8 for the purchase of the Pro-Flow Yellow Hose In An Amount Not To Exceed \$37,650.00

Section 3. This resolution shall take effect immediately upon its adoption.
