The purchase of this vehicles is required to provide staff ample vehicles to perform these tasks efficiently. The vehicles cost, utilizing the Florida Sheriff's Association contract, is \$12,000 below the MSRP. This vehicle is budgeted in this year's Capital Infrastructure Budget. SA22-VEL30.0 FROM GARBER FLEET SALES IN AN AMOUNT NOT TO EXCEED \$36,770.00; AUTHORIZING THE CITY MANAGER TO ENTER INTO AGREEMENTS IN CONNECTION THEREWITH, APPROPRIATING AND EXPENDING FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Purchasing Policies and Procedures allow the City Council to enter into contracts for materials, supplies, equipment, public improvements or services without competitive bidding by utilizing existing contract terms and prices entered into by other local, state or federal governmental authorities that followed a competitive bidding procedure leading to the award of the contract in question; and

**WHEREAS**, the City desires to take advantage of the State of Florida Contract No. SA22-VEL30.0 From Garber Fleet Sales In An Amount Not To Exceed \$36,770.00 for The Purchase Of a Chevrolet Silverado 2500.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

- **Section 1**. The above recitals are true and correct and incorporated herein.
- **Section 2**.
