May was a very busy and active month. Deputies responded to over 5,348 calls for service this month. Deputies still were able to make 117 arrest and Notice to appear cases and 12 DUI investigations. Extra patrols during this hectic time produced an amazing 908 traffic stops this month. All deputies were active in all areas this month.

Marathon Deputies continue to make an impact in our community with local clean ups and community projects.

## **Crime/Arrest Report:**

**Detective White- MCSO23OFF003811 Vessel Burglary** Reporting party called in alleging that Rae Williams had stolen multiple items from Jeremiah Johnson's vessel. Upon speaking with Rae it was learned the items were taken by Rae at Jeremiah's behest. Rae further confessed to helping Jeremiah obtain funds and transportation out of the state to avoid prosecution for his pending homicide charge. A search warrant was obtained for Rae's phone with extraction pending. **Arrest warrant obtained with bond set at \$50,000, Rae was arrested and is currently in Key West Jail.**

**Detective Swire- MCSO23OFF001788 Battery-** A victim reported to road patrol that a suspect came to her job (S.S Wreck and Galley) and touched her groin against her will. K. McGraw asked for assistance in completing her investigation the charge was brought down to simple battery due to the suspect touching the victim on her clothing. The suspect committed the crime on camera he was identified in a photo lineup by 3 witnesses. **The suspect was arrested.**

### **Detective Torres-MCSO23OFF003341 Boat Burglary Duck Key Marina**

Unknown suspect burglarized four vessels taking GPS electronics. Suspect wearing mask, gloves, and long pants/shirt. Detectives canvassed area for surveillance and witnesses. Det. Torres working with Upper Keys detectives. **Investigation on going.**

**Deputy Hradecky-MCSO23OFF004256- TRAFFIC STOP 60TH STREET-** Motorcycle with no tail lights operated by Peter M Barasa. Peter claimed to have license and endorsement in Illinois and Wisconsin. Records check showed Illinois suspended. Unable to verify WI. WI state trooper dispatch called and they verified he never had a license in WI only and ID card. Barasa arrested for DWLS with and no motorcycle endorsement. 2.4 grams of FTP Fentanyl in 6 individual packages located during Inventory of the bike. Further records check showed Barasa was a convicted felon and had not registered.

**Deputy DelCueto-MCSO23OFF003954- TRAFFIC STOP 1480 O/S HWY- MICHAEL BUTTON (FL DL B350555870620) STOPPED BY D/S DEL CUETO FOR ERRATIC DRIVING. MULTIPLE SIGNS OF IMPAIRMENT. SFSE'S CONDUCTED. MICHAEL ARRESTED FOR DUI AND UNLICENSE CARRY OF A FIREARM. BRAC .166.**

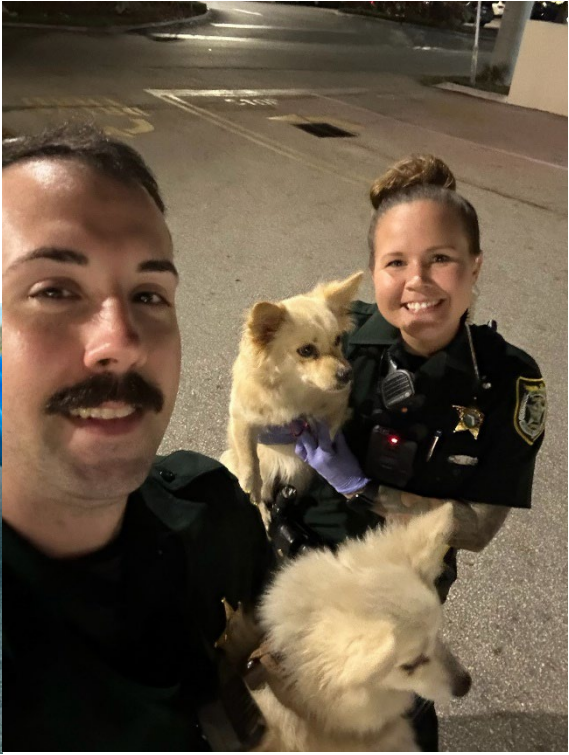

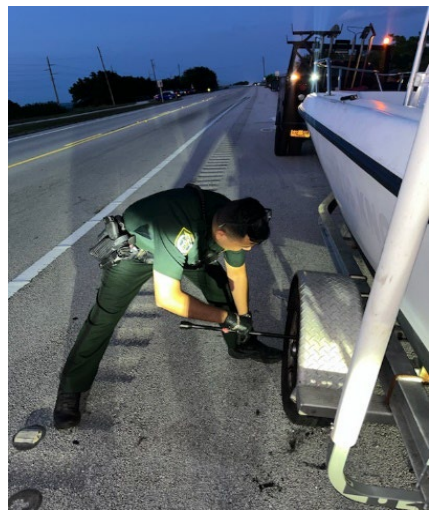
