Agenda Item: **Resolution 2026-05**, Approving An Amendment Revising The Rates For The Vacation Rental Fee Schedule; And Providing For An Effective Date.

### BACKGROUND & JUSTIFICATION:

At the request of Councilman Matlock, staff was asked to review the vacation rental fees based on costs currently absorbed by the local taxpayer. As the City must employ additional staff to cover the population of vacation renters within the City, these fees now include 10% of the budgets of Fire EMS and Parks and Recreation. The total fees incurred per vacation rental (see attached fee schedule) is \$2,202.91. This number is rounded down to a new base license fee of \$2,100.00 and a renewal fee of \$2,000.00. This represents a \$1,000.00 increase to the current fee structure.

This yearly increase in costs will represent a number that can be passed on to the renter (\$19.23 a week or \$2.73 a day). The increased fees will generate an additional \$1,229,000.00 for the City budget. This would represent a 52% decrease in the current fiscal year's deficit spend of \$2,136,92.00.

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
MARATHON, FLORIDA, APPROVING AN AMENDMENT REVISING  
THE RATES FOR THE VACATION RENTAL FEE SCHEDULE; AND  
PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, Section 8-12 (c)(4) of the Code of Ordinances states that the City Council shall create and may amend the fee schedule for vacation rental property licenses and vacation rental agent licenses by resolution; and

**WHEREAS**, the City Council has instructed the City staff to review the fee schedule; and

**WHEREAS**, the City must now employ additional staff to cover the population of vacation renters within the City, which now includes 10% of the budgets of Fire EMS and Parks and Recreation; and

**WHEREAS**, the City continuously incurs the costs of dedicated staff for the review and processing of applications, scheduling of inspections, internet search for illegal advertisements and follow up of compliance with the Vacation Rental regulations; and

**WHEREAS**, the attached fees and rates were developed after much consideration, factual analysis of the increased costs and consultation with the City Manager.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE  
CITY OF MARATHON, FLORIDA, that:**

**Section 1.** The above recitals are true, correct, and incorporated herein by this reference.

**Section 2.** The City Council hereby approves the fees for the issuance and renewal of vacation rental licenses and annual agent licenses attached hereto as Exhibit "A".

**Section 3.** The fees and rates for the issuance and renewal of vacation rental license and agent fees will be reviewed annually and any amendments will be brought before the City Council.

**Section 4.** This resolution shall take effect immediately upon its adoption.

## Vacation Rental Agent License Fee

Must be obtained or renewed before any inspections are done. Paid with completion of vacation rental course. Agent fees are due annually.

Vacation Rental Agent License Fee

\$500.00

As authorized by Section 215.322(5), Florida Statutes, a convenience fee for transactions for any fees listed herein paid by approved credit cards or bank debit cards shall be charged in an amount of two and ninety-nine hundredths' percent (2.99%) of the fees and related charges being paid plus ninety-nine cents (0.99¢). For any fees listed herein paid by E-check via ACH direct-debit from most major banks a two dollar and twenty-five cent (\$2.25) flat fee will be applied.

The convenience fee must be disclosed prior to the completion of the transaction, so that the cardholder may decide whether to cancel the transaction or pay by another method.

In the event of a refund or reconciliation of payment made by the cardholder, the convenience fee is not included in any refund.
