### BACKGROUND & JUSTIFICATION:

The Area 5 wastewater treatment facility was built in 2000 and the existing sewage pumps are no longer supported therefore we are unable to get parts to keep them in operable condition. Due to the fact the pumps must pump against the existing vacuum in the tank, these pumps are the only ones capable of overcoming that suction pressure and therefore the only choice for replacement. The new pumps are a different design and will be more efficient and require less maintenance than the existing system. The proposal includes two (2) pumps and all the required piping and modifications needed for a complete installation.

**WHEREAS**, the City requires an upgrade to the sewage pumping system at the Area 5 treatment plant, and

**Section 1.** The above recitals are true and correct and incorporated herein.

**Section 2.** The City Council hereby authorizes the City Manager to enter into an agreement and expend budgeted funds on behalf of the City to Hudson Pump & Equipment in the amount not to exceed \$95,000.00.

**Section 3.** This resolution shall take effect immediately upon its adoption.
