Matlock commented that the numbers are pretty simple and we have increased the fees a few times on consent. This is not a penalty, and this is not going to crush the industry these numbers are justifiable. If someone gets a building permit, it requires staff time and paperwork, we are not asking others to supplement the permit. Mayor Del Gaizo commented she was surprised at the outcry from a few people, as it is \$1,000 over a year's time. Landry cautioned that there is a small difference between a regulation fee and a tax, someone may sue us and we need to make sure we protect our vacation rental ordinance.

Michael Clark – explained he owned two homes, and one was a vacation rental. He felt the increase was excessive.

Brian Schmitt – commented he was glad to hear it was about cost recovery, but we are surrounded by vacation rental sand they pay more in tax and insurance, but this increase is not fair. Vacation rentals are the only way this town can compete with other tourist destinations in the Keys and jobs rely on vacation rentals and we cannot build any more hotels.

Matlock commented that the \$1,000 was not a number he produced, we were under charging Key Colony Beach for fire service too, and now we are caught up.

Williams explained there had to be a rational nexus, Williams explained we are not changing our ordinance, we have amended our fee structure four times without legal challenges and other Florida cities have amended their fee structures as well, it has been settled throughout the state.

Matlock commented he understood it will cost vacation rental owners more money, but the city has stepped up and hired staff, we pay them and they need vehicles, etc.. costs have gone up; the last increase was four years ago.

Struyf commented that the vacation rentals should pay their fair share, but she did not have the data that was sent out yesterday, and suggested tabling until we have more information.

Landry asked the fire chief if 1,000 vacation rentals disappeared if we would decrease our fire staff. Chief commented possibly the inspection portion but not fire fighters because the structures would still be there.

Del Gaizo commented that she was hoping to hear more from her fellow real estate people, we are going to table but would like to hear from those in the industry. This is not personal; we are talking about \$1,000 over the year. Still asked to look into a step increase as it may be more acceptable.

Sandra Van Dusen, Marathon - commented about the hate in Marathon and the United States in the past year.

In response to the cheers after each speaker, Williams read from Resolution 2017-21 and explained that demonstrations in support or opposition to a speaker or idea such as clapping, cheering, booing, hissing, etc.. are not permitted in Council Chambers.

Fred Swanson, Key Colony Beach – commented he was ashamed of the situation in the country and spoke against ICE and asked the Council to have a resolution for no masks for ICE agents and to stop abducting people.

Peter Levasseur, Marathon – spoke regarding the ugly buildings in the City and no architectural oversite via an architectural review board.

Isave Valdes, Marathon – asked the Council to take a public stance against ICE and create a policy that people are treated with respect.

Diane Scott, Marathon commented that the police treat Black people worse such as tasering without probable cause.

Kristin Battista-Fraze, Big Pine Key – asked the Council to create a resolution protecting the constitutional rights of American citizens. Battista-Fraze commented that the masked agents were specifically targeting people with brown skin and asked that the resolution give immigrants their due process and ban masks.

Barb Haag-Heitman, Key Colony Beach – commented she has been participating in the ICE protest and informed everyone that according to CNN the Border Patrol has been collecting information on protesters.

Brandon Manzier, Marathon – commented on the amount of debris on the bike path and suggested maintenance on the bike path markings as they are faded and educating people where they can safely cross US1.

Mike Aranda, Marathon – spoke briefly about noise reduction of air conditioners and ways to hid them as well as application reviews and recommended the person in charge of reviewing the application not be the person to whom the appeal goes.

Barbara Herrington-Clemens, Marathon – spoke about traffic issues, especially Sombrero Blvd. speeding.

Debbie Hickey, Marathon – asked about an update on the golf course project if the plans have changed – Roussin explained the plans have not changed.

Diane Scott, Marathon - spoke about her nuisance neighbor and the utility candy cane issues.

Brewster Rhoads, Big Pine Key – spoke about his concerns with ICE at the national and local level.

Peter Levasseur, Marathon - questioned if there was any interest in an architectural review board. Struyf commented that the City has a duty to care about the character of the community. Garrett commented that he felt a review board was not a bad idea.

Reit Steinmetz, Marathon – spoke about bike safety on Aviation Blvd. and stop signs Landry commented that education is a big part. Struyf questioned Garrett about the plans for stop signs and Garrett responded that DOT takes a while, we could look at their five-year plan.

Kristin Battista-Fraze, Big Pine Key questioned what the process is to discuss policies, and she would like to see a resolution of values.

Mike Aranda, Marathon – asked if we could just put the stop signs back. Garrett informed him it is FDOT right of way.

Diane Culver, Marathon – commented that when we see our fellow citizens being targeted, they need to know we have their back. Culver spoke about the February 3<sup>rd</sup> immigration status date for Hatians.

Mayor Del Gaizo commented that the Council does care, this affects everyone, we are going to Tallahassee next week, and our problems are the same everywhere. Struyf commented that we have our hands tied to a point, we are having an open conversation, people see both sides. Struyf suggested bringing solutions, and although we may have different opinions, we are willing to listen. Still reiterated that all of the Council is willing to listen even if we have different opinions. Landry commented that we have an open-door policy, we do not have offices here, but our phone numbers and email addresses can be found on the City’s website. Del Gaizo suggested signing up for the City’s newsletter to find out what is going on in the City.
