Agenda Item: **Resolution 2026-27**, Awarding The Contract For The Area 3 Influent Piping System Upgrade To Reynolds Construction, LLC In An Amount Not To Exceed \$126,870.00; Authorizing The City Manager To Enter Into Agreements In Connection Therewith, Appropriating And Expending Budgeted Funds; And Providing For An Effective Date

BACKGROUND & JUSTIFICATION:

The Area 3 wastewater treatment facility has existing 8” influent piping which is causing the influent screen to overflow during higher flow periods. The existing piping is ductile iron and is corroding after 20 years. This upgrade replaces the existing 8” ductile iron piping with 12” Schedule 80 PVC piping which will reduce the velocity to the screen and eliminate the overflows. Also included in this upgrade is the re-piping of the existing force main that is causing water hammer and several valve replacements. Several plant shutdowns will be required to accomplish this scope of work.

Mr. Saus:

Reynolds Construction (RC) appreciates the opportunity to assemble a proposal to replace and upgrade the in-ground vacuum tank effluent piping and replace the static screen influent piping and plug valve.

Based on our jobsite visit with the operations and collections staff on January 20th and current material pricing Reynolds proposes to complete the scope of work as follows:

- \$126,870.00. (One hundred twenty-six eight hundred seventy dollars and zero cents).

Scope of work includes:

- Removing and replacing the existing DI MJ cross, tees, bends while replacing the fittings to reduce the hammer effect being felt on the system.
- Removing the eight-inch bypass of the headworks influent and tie into the existing eight-inch HDPE line.
- Installation of a line stop prior to performing the necessary shutdowns. Shutdowns shall be performed during low-flow hours of operation.
- Installing new replacement in-ground valves for the effluent line. (collections team to purchase valves)
- Installation of an eight-inch gate valve to help close flow coming back into the vacuum tank.
- Replacing all eight-inch ductile iron static screen influent piping with twelve-inch PVC.
- Install a new twelve-inch double wedge gate valve and install a 316SS support.
- Coatings of exposed piping.
- Equipment for Reynolds scope of work.

Scope of work does not include:

- Permitting from the City of Marathon.
- All hydro-excavation, backfill placement, compaction and asphalt modifications.
- Electrical conduit, wiring and modifications in-ground.
- Purchasing of in-ground replacement valves.

Thank you for allowing Reynolds the opportunity to assist with the efforts to assist the City of Marathon.

Area 3 - Vacuum Effluent & Headworks Influent Piping Upgrades

- Reynolds to assist the City of Marathon with upgrading the Area 3 vacuum tank effluent and headworks influent piping and valves.
- Work is anticipated to include two (2) night time, low-flow shutdowns.
- Reynolds also to replace MJ Cross, 6x3 MJ reducer, & install plug valve outside Area 3 building.
- Reynolds will enlist a line stop subcontractor to close off the 8" HDPE influent line prior to start of the shutdown.
- Plug valve costs and labor is included in PO 230066 to replace the original SDR21 line.
- Reynolds will change line from a 4-way cross into a single line with two MJ 6" WYEs that branches to the other two lines. The southside line will then reduce to 3".
- Materials for replacing MJ cross with WYE fittings have already been bought and paid for by the City of Marathon. These are not included in the attached proposal
- Reynolds will reconfigure the static screen influent line to help reduce the hammer effect being felt throughout the vacuum system.
- Reynolds will also remove the entire the 6" vac line that branches off the 8" main effluent line.
- Reynolds will also replace three (3) 6x3 TEEs and swap them for MJ 3" 45 elbows and 6x3 WYEs to help with the hammer effect being felt on the system.
- The City of Marathon's collection team will be responsible for all hydro-excavation of the job site with the vac truck.
- Quote is valid for thirty (30) calendar days from the transmission of the proposal.


