RESOLUTION 2026-XX**

**A RESOLUTION OF THE CITY COUNCIL OF MARATHON, FLORIDA,  
ADOPTING THE CITY OF MARATHON ROADWAY VULNERABILITY  
STUDY; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City of Marathon entered into an interlocal agreement with Monroe County under Resolution 2024-08 regarding roadway vulnerability analysis; and

**WHEREAS**, Monroe County agreed to manage the work ("Work") conducted during this Project, and the roadway vulnerability analysis would only be conducted on roads within the four municipalities of Islamorada, Layton, Key Colony Beach and Marathon and the road elevation data collected during the project would be added to LiDAR data collected in Monroe County previously; and

**WHEREAS**, the roadways maintained by the City were evaluated to develop a long-term roads adaptation plan based on design criteria, Sea Level Rise (SLR) projections developed by WSP (Formerly Wood) under the Monroe County Roadway Vulnerability Analysis and Capital Plan, adaptation methodology, policy/financing evaluation, and public/stakeholder outreach; and

**WHEREAS**, The primary objective of the project is to analyze the impacts of current and projected levels of SLR on the municipal-maintained roads and develop an implementation plan and timeline to adapt roads for SLR.; and

**WHEREAS**, The roadway vulnerability study will be used to determine new policy considerations and design criteria for what acceptable levels of service should be; and

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, that:**

- Section 1.** The above recitals are true and correct and are incorporated herein.
- Section 2.** The City of Marathon Roadway vulnerability Study is hereby adopted.
- Section 3.** This resolution shall take effect immediately upon its adoption.
