Agenda Item: **Resolution 2026-60** Awarding a contract for EMERGENCY repairs of the Knights Key Lift station to FJ Nugent & Associates, Inc. In An Amount Not To Exceed \$44,851.00; Authorizing The City Manager To Enter Into Agreements In Connection Therewith, Appropriating And Expending Budgeted Funds; And Providing For An Effective Date

BACKGROUND & JUSTIFICATION:

The Knights Key lift station had a major failure of the actual wet well sump walls. The age of the concrete and the depth involved has caused increased hydraulic pressure over the year and infiltration was getting out of control. The excess salt water was threatening to overwhelm our collection system and plant. These repairs planned to restore the station to full functionality with no saltwater intrusion. This Resolution ratifies the already completed emergency repairs.

WHEREAS, the City required an emergency repair of the Knights Key Lift Station because it failed underground and was causing massive salt water intrusion, and

WHEREAS, FJ Nugent installed the lift station equipment and is the sole source contractor for these pump stations with the city, and,

WHEREAS, staff recommends this contract for approval.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

Section 1. The above recitals are true and correct and incorporated herein.

Section 2. The City Council hereby authorizes the City Manager to enter into an agreement and expend budgeted funds on behalf of FJ Nugent and Associates, Inc. in the amount not to exceed \$44,851.00.

Section 3. This resolution shall take effect immediately upon its adoption.
