RESOLUTION NO. 2022-72

A RESOLUTION OF THE CITY COUNCIL OF MARATHON, FLORIDA, APPROVING AND ACCEPTING A WARRANTY DEED FOR THE CONVEYANCE OF LAND FROM SEASONS 16 LLC; HAVING REAL ESTATE NUMBER 00369550-000000; AUTHORIZING ITS RECORDING IN THE PUBLIC RECORDS OF MONROE COUNTY, FLORIDA; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 106.59 of the City Code, a landowner may voluntarily elect to dedicate to the City a vacant, conservation lot that has restricted development through a conservation easement; and

WHEREAS, if a landowner proposes to dedicate land to the City as set forth above, the landowner is required to execute a statutory warranty deed conveying such land to the City that must be approved by the City Council prior to its recording in the public records of Monroe County, Florida.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF MARATHON, FLORIDA, AS FOLLOWS:

- <u>Section 1.</u> <u>Acceptance of Land Dedication</u>. Subject to payment of all taxes and review and approval by the City Attorney, the Statutory Warranty Deed (the "Deed"), submitted by Seasons 16 LLC attached as Exhibit "A" is approved and accepted by the City.
- <u>Section 2.</u> <u>Public Purpose.</u> The City Council finds and determines that the property being dedicated to the City is within an area proposed for conservation or resource protection and shall be held or used for public purposes, specifically for conservation and resource protection use. The City Clerk is directed to forward a copy of this resolution to the Monroe County Property Appraiser and Tax Collector.
- <u>Section 3.</u> <u>Recording.</u> Seasons 16 LLC shall record, at their sole expense, the Deed in the public records of Monroe County, Florida.
- **Section 4. Effective Date.** That this Resolution shall become effective immediately upon its adoption.
