BACKGROUND & JUSTIFICATION:

The Florida Department of Economic Opportunity (DEO) awarded the City a \$5,000,000 grant for the Purpose of Implementing the CDBG0DR Home Buyout Program in order to reduce flood risk in future hurricane events.

The offer amount of \$300,000 was accepted by the property owners and approved by the Florida Department of Economic Opportunity.

The Department of Economic Opportunity has given approval for the City of Marathon to move forward with the purchase of this property.

The City of Marathon will demolish any structures on the property and restore the property to a green space, stormwater drainage, or for recreational purposes in perpetuity.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVING THE PURCHASE AMOUNT FOR PROPERTY AT 592 83rd STREET OCEAN, MARATHON, FL, PARCEL ID 00347630-000000; APPROPRIATING FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Marathon has accepted a \$5,000,000 Grant Award from the Florida Department of Economic Opportunity (DEO) for the Purpose of Implementing the CDBG-DR Home Buyout Program to reduce flood risk and repetitive property loss in future hurricane events.; and

WHEREAS, the City of Marathon has made, the property owners accepted, an offer of \$270,000 to purchase the property at 592 83RD Street Ocean, Marathon, Parcel ID 00347630-000000; and

WHEREAS, DEO has given final approval, the City of Marathon will complete the purchase of the property at 592 83RD Street Ocean, Marathon, Parcel ID 00347630-000000; and

WHEREAS, the City of Marathon will commit to demolishing any structures on the property and restore the property to a green space, stormwater drainage, or for recreational purposes in perpetuity; and

WHEREAS, the Marathon City believes the purchase of this property will help mitigate the area against future loss due to flooding.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

Section 1. The above recitals are true and correct and are incorporated herein

Section 2. The City of Marathon will coordinate with the property owners and the Florida Department of Economic Opportunity for the Closing.

Section 3. This resolution shall take effect immediately upon its adoption.
