

## FINAL PUBLIC NOTICE

The Federal Emergency Management Agency (FEMA) has received the subgrant application for the City of Marathon's City Marina repairs due to damages in Hurricane Irma (DR-4337-FL PW 05654). Pursuant to Executive Order 11988 and 44 CFR Part 9.12, final notice is hereby given of FEMA's intent to provide funding for this project under the Public Assistance (PA) Program.

An initial disaster-wide Public Notice was published October 6, 2017 for Hurricane Irma. Comments and other information received were fully evaluated by FEMA along with evaluation of social, economic, environmental, and safety considerations. This notice serves as a project-specific final notice for FEMA's funding action located within the floodplain.

Funding for the proposed project will be conditional upon compliance with all applicable federal, tribal, state and local laws, regulations, floodplain standards, permit requirements and conditions. This action complies with the National Flood Insurance Program (NFIP) requirements.

- Floodplain:** Project is located in the AE zone, otherwise known as the area of 100-yr flooding, per Monroe County FIRM Panel # 12087C1379 K, dated 02/18/2005.
- Proposed Work and Purpose:** The City of Marathon will repair the City Marina to restore the facility back to its pre-disaster conditions. Repair work will include the communication tower, floating docks, a landing pier, a sea wall, boat lifts, piles, fencing, electrical components, and replacing contents. The City of Marathon will mitigation flood risk in the future by replacing hollow concrete with solid wood pilings and by building a loft for contents and files to be relocated to prior to another event. The City of Marathon is responsible for obtaining any necessary USACE and FDEP permits for the work and for confirming compliance with permit conditions.
- Project Alternatives:** The alternative that has been considered is the no action alternative. This alternative is not feasible as the area will remain vulnerable to flood risk, including property damage and hazards to human life and safety. With the no action alternative, continued negative impacts on adjacent infrastructure, property, residents, and the community may be experienced. Alternate locations were not considered as the marina is functionally dependent upon its location within the floodplain.
