PLANNING COMMISSION RESOLUTION NO. 2003-129

A RESOLUTION OF THE CITY OF MARATHON PLANNING COMMISSION, APPROVING THE MARKET RATE RESIDENTIAL DWELLING UNIT ALLOCATION FOR QUARTERS 1 THROUGH 4 AND AFFORDABLE HOUSING RESIDENTIAL DWELLING UNIT ALLOCATIONS FOR QUARTER 1, YEAR 12, PURSUANT TO SECTION 9.5-124 OF THE CITY OF MARATHON, LAND DEVELOPMENT REGULATIONS

WHEREAS, on the 14th day of October, 2003, the Planning Commission (the Commission) conducted a properly advertised public hearing regarding the Residential Dwelling Unit Allocation Evaluation Report submitted by the Planning Manager pursuant to Section 9.5-122.2 of the Code (the "Staff Report").

NOW, THEREFORE, BE IT RESOLVED BY THE PLANNING COMMISSION OF THE CITY OF MARATHON AS FOLLOWS:

Section 1. Findings of Fact.

- (1) The Public Hearing was properly advertised and held, as required by law, and the Applicant(s) and all interested parties concerned in the matter were given an opportunity to be heard.
- (2) Based upon the Staff Report, the Commission approves the Planning Manager's recommendation of the ROGO applications rankings for:
 - a. Market Rate Housing quarter 1 through 4, Year 12 of ROGO.
 - b. Affordable Housing quarter 1, Year 12 of ROGO

Section 2. Conclusions of Law.

Based upon the above Findings of Fact, the Commission does hereby make the following Conclusions of Law:

- (1) The ROGO applications for quarters 3 and 4 of year 8 of ROGO have been processed in accordance with Section 9.5-122 of the Code.
 - (2) In rendering its decision, as reflected in this Resolution, the Commission has:
 - (a) Accorded procedural due process;
 - (b) Observed the essential requirements of the law; and
 - (c) Supported its decision by substantial competent evidence of record.
- (3) Based upon the Staff Report, the Commission hereby **GRANTS** of allocations to applicants ranked one (1) through nineteen (19) for Market Rate Dwelling Units; and

(4) Based upon the Staff Report, the Commission hereby **GRANTS** one (1) allocation to the applicant ranked one (1) for Affordable Rate Dwelling Units; and

Section 3. Effective Date.

That this Resolution shall become effective immediately upon its adoption.
