A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AMENDING THE CITY'S WASTEWATER UTILITY RATE SCHEDULE TO ADD A NEW CLASS OF WASTEWATER SERVICES FOR "VESSEL WASTE" AND A CORRESPONDING FEE; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Council of the City of Marathon, Florida (the "City") enacted Ordinance 02-07-12 and Ordinance 2008-10 (the "Ordinances), which establish a Wastewater Utility and authorizes, by City Council resolution, the creation of different classes of wastewater services and the imposition of fees, charges and procedures for the construction, operation and maintenance of the wastewater system, as appropriate; and

WHEREAS, based upon the need for a vessel waste disposal location, the City Council has determined that providing a location for disposal is essential to the protection of water quality in Marathon and the Florida Keys as well as provides a valuable service to the boating community; and

WHEREAS, the City Council desires to append the operations and maintenance rates and other fees to be effective immediately for the City's Wastewater Utility.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

- **Section 1**. The above recitals are true and correct and incorporated herein.
- **Section 2.** This resolution is adopted pursuant to the provisions of Ordinance No. 2001-10, Ordinance No. 02-07-12, Sections 166.021 and 166.041, Florida Statutes, and other applicable provisions of law.
- **Section 3.** The amended Wastewater Utility Rate Schedule, which includes a new class, entitled "Vessel Waste," attached hereto as Exhibit "A" is hereby adopted.
 - **Section 4**. This resolution shall take effect immediately upon its adoption.

Monthly Rates for Vessel Waste Disposal:

- 1. Vessel Waste Operations and Maintenance Charges \$112.00 / month
- 2. CBOD surcharge
