DECLARATION OF OFFICIAL INTENT OF LOCAL GOVERNMENT

For Reimbursement of Expenditures from Tax-Exempt Bonds/Notes Pursuant to Treasury Regulations § 1.150-2

- 1. Date of this Declaration of Official Intent: Detagral, 2014
- Local Government's Name: CITY OF MARATHON ("Local Government")
- Description of expenditures to be reimbursed from the proceeds of State of Florida Department of Environmental Protection, Everglades Restoration Revenue Bonds (the "Bonds"):
 - Description of expenditures to be reimbursed: Expenditures will be by the Local Government a. for the purpose of financing the cost of constructing sewage collection, treatment, and disposal facilities included in the Florida Keys Area of Critical State Concern protection program.
 - Maximum amount of debt proceeds expected to be received by the Local Government for its b. Project expenditures: \$17,000,000.
- The expenditures described in Section 3 are capital expenditures under general federal income tax principles.
- The Local Government declares that it intends that its expenditures described in Section 3 will be reimbursed from the proceeds of the Bonds issued by the State of Florida Department of Environmental Protection, through the Division of Bond Finance of the State Board of Administration of Florida.
- The Local Government does not have a pattern of failing to reimburse from borrowed money advances made for expenditures which it previously declared or otherwise indicated would be so reimbursed.
