CITY OF MARATHON, FLORIDA RESOLUTION 2016-34

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA; PROVIDING FOR A NON-BINDING REFERENDUM BALLOT MEASURE TO BE PRESENTED TO THE ELECTORS OF THE CITY **CONCERNING** THE **CONSTRUCTION** AND MAINTENANCE OF A COMMUNITY POOL, TO BE SUBMITTED TO THE ELECTORS IN CONJUNCTION WITH THE PRIMARY ELECTION \mathbf{ON} TUESDAY. AUGUST 30, 2016; PROVIDING REQUISITE BALLOT LANGUAGE FOR SUBMISSION TO THE ELECTORS: PROVIDING FOR NOTICE OF ELECTION; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council is authorized to call for a non-binding referendum vote by the electors of the City; and

WHEREAS, the City Council desires to submit to the electors of the City a non-binding referendum concerning the construction and maintenance of a community pool, as described herein.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AS FOLLOWS:

Section 1. The above recitals are hereby confirmed and adopted.

Section 2. That a non-binding referendum election is hereby called, to be held in conjunction with the primary election, for Tuesday, the 30th Day of August, 2016, to present to the electors of the City of Marathon the proposed question provided in Section 3 of this Resolution.

Section 3. That the form of non-binding referendum ballot for the question provided for herein shall be substantially as follows:

CONSTRUCTION AND MAINTENANCE OF A COMMUNITY POOL

Section 4. That balloting shall be conducted between the hours of 7:00 a.m. until 7:00 p.m. at the regular polling places for general elections. All qualified City electors who are timely registered in accordance with law shall be entitled to vote. The City's officials are authorized to obtain any necessary election administration services from the Monroe County Supervisor of Elections.

Section 5. That notice of said election shall be published in accordance with Section 100.342, Florida Statutes, in a newspaper of general circulation within the City at least 30 days prior to said election, the first publication to be in the fifth week prior to the election (to-wit: during the week commencing July 25, 2016), and the second publication to be in the third week prior to the election (to-wit: during the week commencing August 8), and shall be in substantially the following form:

"NOTICE OF NON-BINDING REFERENDUM ELECTION

PUBLIC NOTICE IS HEREBY GIVEN THAT PURSUANT TO RESOLUTION NO. 2016-14 ADOPTED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA (THE "CITY") A NON-BINDING REFERENDUM ELECTION HAS BEEN CALLED AND ORDERED TO BE HELD WITHIN THE CITY, IN CONJUNCTION WITH THE PRIMARY ELECTION, ON TUESDAY, AUGUST 30, 2016, BETWEEN THE HOURS OF 7:00 A.M. AND 7:00 P.M., AT WHICH TIME THE FOLLOWING NON-BINDING REFERENDUM BALLOT MEASURE SHALL BE SUBMITTED TO THE QUALIFIED ELECTORS OF THE CITY.
