A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVING A SECOND AMENDMENT TO THE MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE MONROE COUNTY SCHOOL DISTRICT DIVISION OF CAREER AND TECHNICAL EDUCATION (MCSD) AND THE CITY OF MARATHON, FLORIDA, FOR MCSD'S 2021-22 FIRE ACADEMY AT MARATHON HIGH SCHOOL TO CONTINUE TO PROVIDE FIRE FIGHTING TRAINING TO HIGH SCHOOL AND ADULT STUDENTS IN AN AMOUNT OF \$50,000 PER YEAR FOR EACH SUCCESSIVE SCHOOL YEAR UNTIL TERMINATED WITH 60 DAYS NOTICE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, this program assists in the great need for training and hiring local employees, and the School District as well as the City would like to continue this successful program. The intended purpose of this program would be to train local students with the intent for them to become employed with the City of Marathon; and

WHEREAS, the amended term in the agreement will be for each successive school year until terminated in writing by either party with 60 days' notice.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, that:

- **Section 1**. The above recitals are true and correct and incorporated herein.
- **Section 2**. The City Council authorizes the City Manager to enter into a Second Amendment of the MOU with the Monroe County School District Division of Career and Technical Education (MCSD) for the FY2021-22 school year, attached hereto as Exhibit "A," together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney is hereby approved.
 - **Section 3**. This resolution shall take effect immediately upon its adoption.

SECOND AMENDMENT OF MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE MONROE COUNTY SCHOOL DISTRICT DIVISION OF CAREER AND TECHNICAL EDUCATION (MCSD) AND THE CITY OF MARATHON FOR

THE PROVISION OF FIRE FIGHTING TRAINING SERVICES

This SecondAmendment to the MOU for the Provision of Fire Fighter Training Services (the "Amendment") made and entered into this Sday of June between the City of Marathon, Florida, a municipal corporation organized and existing under the laws of the State of Florida, with its address at 9805 Overseas Highway, Marathon, Florida, 33050 (hereinafter referred to as "City") and Monroe County School District Division of Career and Technical Education, with its address at 241 Trumbo Road, Key West, Florida (hereinafter referred to as "MCSD").

WITNESSETH:

WHEREAS, MCSD and the City entered into an MOU for the Provision of Information Fire Fighting Training Services; and

WHEREAS, the City and Consultant desire to amend the Agreement to term to renew for each successive school year until terminated in writing by either party with 60 days notice; and

NOW THEREFORE, in consideration of the mutual promises and covenants set forth in this Amendment and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereby amend the MOU to read as follows:

1. **TERM**

This Memorandum of Understanding (MOU) shall remain in effect until terminated with sixty (60) days' notice in writing and executed by both parties.
