WHEREAS, the Staff now recommends the City Council to approve Change Order #2 for the additional work described to the proposal from Tropical Underground, in an amount not to exceed \$44,174.91, as provided on Exhibit "2".

Except as herein or heretofore expressly modified, all terms of the Agreement shall remain in full force and effect and shall cover the performance of, and payment for, any work authorized hereunder. Any defined terms not defined in this Change Order shall have the meanings set forth in the Agreement.

By signing below the parties indicate acceptance of this Change Order as set forth herein.

The cost for this includes supply and installation of a bismarck palm, crinum lilies, red copper leaves, silver buttonwoods, ornamental grass, green island ficus, St. Augustine SOD, top soil, removal and disposal of existing damaged material, irrigation modification, pick up and delivery of field grown palm and small plant material, and heavy equipment rental and delivery.
