RESOLUTION 2026-14**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA RENEWING THE TURF AND LANDSCAPE MAINTENANCE AGREEMENT WITH FDOT FOR THE MAINTENANCE OF THE US 1 CORRIDOR WITHIN THE CITY OF MARATHON; AUTHORIZING THE CITY MANAGER TO EXECUTE THE FIRST ONE YEAR RENEWAL AGREEMENT; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the FDOT ( Florida Department of Transportation) (the “DEPARTMENT”) has jurisdiction and maintains State Road 5/US-1 /Overseas Highway within the FDOT right of way from the Seven Mile Bridge to the West end of Tom’s Harbor Bridge Channel (Bridge # 900100) in the City of Marathon in (the “LOCAL GOVERNMENT”); and

**WHEREAS**, the DEPARTMENT, at the LOCAL GOVERNMENT’s request, has agreed to compensate the LOCAL GOVERNMENT for the maintenance of turf and landscape, hereinafter referred to as (the ‘PROJECT’), and

**WHEREAS**, the Department and the LOCAL GOVERNMENT entered into an Agreement whereby the Department retained the Contractor to perform maintenance of all turf and landscape areas within the right-of-way on the State Roads described in "Exhibit A" of the original contract; and

**WHEREAS**, said Agreement has a renewal option which provides for a renewal if mutually agreed to by both parties and subject to the same terms and conditions of the original Agreement; and

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:**


**Section 1.** The above recitals are true and correct and incorporated herein.

**Section 2.** The parties agree to a renewal of said original agreement for a period beginning the 1 day of July, 2026 and ending the 30 day of June, 2027 at a cost of \$53,000.00. All terms and conditions of said original agreement shall remain in force and effect for this renewal, a copy of which is attached as Exhibit “A,” together with such non-material changes as may be acceptable to the City Manager and approved as to form by the City Attorney, is hereby approved for a one-year renewal. The City Manager is authorized to execute a one-year renewal of the Contract on behalf of the City.

**Section 3.** This resolution shall take effect immediately upon its adoption.
