**WHEREAS,** The City shall use this report to determine transfer costs for the interlocal agreement and will also be used for the City Comprehensive Plan.

Section 3.     Effective Date. This Resolution shall become effective immediately upon its adoption.



We are pleased to submit this proposal for Professional Civil Engineering Services for the City of Marathon. This proposal includes the following detailed description of services:

**I. SCOPE OF SERVICES**

Calvin, Giordano & Associates, Inc. will field visit all public roads, street lights, buildings, bike paths, parks and all other public facilities identified within the City of Marathon that can be transferred from Monroe County to the City of Marathon.

The field visits will include an inventory, a visual inspection and an analysis of the condition of the facilities. If the facility is found to be substandard an improvement plan will be prepared that will detail improvements that need to be made and the associated costs.

A report will be issued within forty-five (45) days of authorization of this proposal. This report shall be used to determine transfer costs for the interlocal agreement and will also be used for the City Comprehensive Plan.

**II. BASIS OF COMPENSATION**

Compensation for the referenced work will be on a lump sum basis with the lump sum fee being \$43,056.00 based on the above scope. A detailed breakdown is provided as follows:


