**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVING THE AWARD OF A CONTRACT FOR GENERAL ENGINEERING AND LANDSCAPE ARCHITECTURE SERVICES BETWEEN THE CITY OF MARATHON AND CALVIN, GIORDANO & ASSOCIATES, INC. TO PROVIDE ENGINEERING, LAND SURVEYING AND LANDSCAPE ARCHITECTURE SERVICES TO THE CITY OF MARATHON; AND AUTHORIZING THE MAYOR TO EXECUTE SAID AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.**

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AS FOLLOWS:**

Section 1.    Recitals.    The above recitals are true and correct and are incorporated herein by this reference.

Section 2.    An award for General Engineering and Landscape Architect services between the City of Marathon and Calvin, Giordano & Associates, Inc..

Section 3.    The Mayor is authorized to execute said agreement, subject to final approval of the terms and conditions of the Agreement by the City Manager and City Attorney.


**II. BASIS OF COMPENSATION**
