## RULES AND REGULATIONS

All facilities are on a "first-come, first-served' basis, according to a priority list scheduling, and are to be used, along with equipment, for the purpose for which they were designed. No physical changes in facility layout are permitted.

The applicant is responsible for the conduct of each individual within the group; profanity and gambling is not be allowed.

Possession or consumption of alcohol is prohibited at the Community Parks unless approved by the City Manager or City Council. No glass containers allowed in the park areas.

No pets are allowed on the athletic fields at any time.

The applicant assumes all risk in the use of the facility and shall be solely responsible and answerable in damage for all accidents and injury to person or property.

A Certificate of Insurance for proof of liability coverage may be required. The City of Marathon will be listed as the Certificate Holder.

The applicant shall be called upon to reimburse the City of Marathon for any damages to buildings, grounds, equipment, or property thereon.

No motor vehicles are allowed on any of the athletic fields.

The applicant shall observe, obey and comply with these rules and regulations as well as all applicable City, County, State or Federal Laws, rules and regulations. Failure to abide by these rules will cause application to be null and void immediately.

City of Marathon Parks and Recreation activities take precedence over any other applicant activity.
