

FINAL PUBLIC NOTICE

The Federal Emergency Management Agency (FEMA) has received the subgrant application for City of Marathon's Waste Water Treatment Plants repairs due to damages in Hurricane Irma (DR-4337-FL PW 06237). Pursuant to Executive Order 11988 and 44 CFR Part 9.12, final notice is hereby given of FEMA's intent to provide funding for this project under the Public Assistance (PA) Program.

An initial disaster-wide Public Notice was published October 06, 2017 for Hurricane Irma. Comments and other information received were fully evaluated by FEMA along with evaluation of social, economic, environmental, and safety considerations. This notice serves as a project-specific final notice for FEMA's funding action located within the floodplain.

Funding for the proposed project will be conditional upon compliance with all applicable federal, tribal, state and local laws, regulations, floodplain standards, permit requirements and conditions. This action complies with the National Flood Insurance Program (NFIP) requirements.

- Floodplain:** Project is located in the AE Zone per Monroe County FIRM Panels #12087C1382K; 12087C1164K; 12087C1381K; 12087C1377K; 12087C1379K; 12087C1379K dated 02/18/2005.
- Proposed Work and Purpose:** The City of Marathon is in the process of repairing and replacing multiple damaged components at six (6) Waste Water Treatment Plants throughout Monroe County. Along with making these repairs, there is a mitigation proposal to elevate concrete tank slabs and chemical pumps, raise all electrical chemical tank and chemical skid components to a minimum of 1 foot above the base flood elevation, tie-down and anchor accessories, and install power conditioners at five of the six sites.
- Project Alternatives:** Moving these damages to an alternative location is not practicable because they are part of a larger critical facility that must remain in service to protect the health and safety of the community. The no action alternative is not feasible because forgoing work would also adversely impact the health and safety of the community.
